## Introduction to Program

The Gulf Research Center Foundation (GRCF) and the Geneva Graduate Institute (IHEID) Executive Education Department focus on delivering high-level executive education and leadership programs to equip participants with practical policy skills. Its flagship initiative, the **World Diplomacy Program**, consists of five intensive modules held over one week, addressing key regional security, economic, and political challenges.

The program will enhance leadership capabilities and strategic understanding of mid-level professionals engaged with critical global issues. It is specifically designed for government officials and diplomats seeking to enrich their professional knowledge and expertise.

The **World Diplomacy Program** takes place in Geneva, Switzerland. This ideal location lies in the heart of Europe, allowing access to a host of governments and international organizations.

To improve the knowledge of mid-level professionals sitting at the crucial intersection of politics, defense and economics about global developments and their impact on state and society

To discuss and analyze current, previous as well as anticipated critical political, economic and security- related issues concerning global developments

To create a unique learning environment by inviting senior scholars and practitioners from a number of different fields in an interactive atmosphere of debate

To enable participants and experts to exchange their ideas and broaden their network of relevant professionals

## Concept and Aim

In today's interconnected world, the boundaries between security, politics, and economics are increasingly blurred. Challenges such as armed conflict, economic instability, and human rights concerns demand integrated responses, where leaders must transcend traditional silos and engage across disciplines and geographies.

The global security landscape is undergoing profound transformation. Emerging and hybrid threats—ranging from terrorism and extremist networks to cyberattacks, disinformation, non-state actors, and transnational crime—are no longer isolated events but part of a broader, interconnected system of instability. In the Gulf region, these dynamics are particularly pronounced given the region's strategic importance and its exposure to regional tensions, fragile neighboring states, and external power rivalries.

While the state remains central in international relations, security has become decentralized, multifaceted, and increasingly shaped by non-traditional actors. For Gulf states, this means developing adaptive national security strategies that account for both hard power threats and soft power vulnerabilities, including energy insecurity, border instability, and the risks posed by climate-related disruptions.

At the political level, globalization continues to alter the role of the state, challenging long-standing governance structures and raising questions about sovereignty, legitimacy, and regional influence. In the Gulf, evolving political dynamics—shaped by youth populations, economic diversification, and heightened geopolitical competition—require diplomacy that is agile, strategic, and grounded in regional realities.

Mediation and dialogue are now critical tools in managing conflict, particularly in the Gulf's wider neighborhood, from Yemen and Iraq to Syria and Sudan. Regional actors, including Gulf states, are increasingly stepping into leadership roles to mediate disputes and stabilize volatile environments. This shift highlights the growing importance of Gulf-led diplomacy and the potential for locally driven solutions.

On the economic front, the future of trade and global markets is being reshaped by shifts in energy, technology, and labor. The Gulf's economic diversification strategies—underpinned by Vision 2030-type frameworks—seek to re-balance reliance on hydrocarbons, attract investment, and integrate into global trade systems. At the same time, the region must navigate disruptions in supply chains, labor mobility, and technological change.

Crucially, the global economic order is under strain. From the 2008 financial crisis to ongoing energy market volatility and a contested global development agenda, questions persist around equity, resilience, and fair distribution of wealth. For the Gulf, this creates both challenges and opportunities: to assert economic leadership, leverage strategic geographic positioning, and contribute meaningfully to global economic governance.

Against this backdrop, this program explores how diplomacy, negotiation, and mediation intersect with the evolving political and security landscape in the Gulf and beyond—while also considering the economic futures being forged in this time of global transition.



## Target Audience

Ideal participants include senior officials and practitioners engaged in foreign policy, security, economic affairs, and strategic decision-making; representatives from the diplomatic community and public-sector institutions; and experts from policy, research, and government-affiliated analytical bodies.

## Methodology

The course employs an immersive and interactive teaching approach that combines expert-led lectures, case studies, group-based problem-solving, participant-driven panels, and hands-on simulation exercises.

Participants benefit from a dynamic mix of academic rigor and real-world experience: sessions are led by a blend of resident faculty, field practitioners, and international experts who bring both policy and operational perspectives to the table.
